DECISION

SUBJECT: "Prohibition of traffic - anchoring - approach of ships/vessels and fishing in the marine area of the island of Atokos".

 - The need to take measures to protect the marine ecosystem, safety of bathers and the preservation of order in the movement and anchoring of the marine area around Atokos

Taking into account the above:

1. For the period from May 1st to October 31st of each year, the following apply:

Prohibitions around the island of Atokos and at a distance of less than three hundred (300) meters from the coast:

- i) prohibition of setting down any type of anchorage, moorings and any type of mooring vessels from fixed or non-fixed points on the coast by extending ropes or other means,
- ii) prohibition of approach and movement of all types of ships, boats, vessels, boats and marine recreational vehicles, for private and professional use,
 - iii) prohibition of recreational and professional fishing,
 - iv) prohibition of sea bathing and any recreational activity,

as well as a ban on landing and disembarking on the coast.

2. Violators of this decision, regardless of any concurrent criminal and/or other responsibilities that accrue, according to the applicable legislation, are subject to administrative sanctions
